

## **Message to all JAMCOPY affiliates sent by email on January 23, 2020**

Dear Affiliates,  
I wish for you all a Happy New Year.

As you would be aware, JAMCOPY has implemented a Revised Distribution Model, which was being phased in over the last 3 years. The Distribution Model is the basis on which we distribute or pay royalties to our affiliates.

Affiliates were informed of the revision at the 2017, 2018 and 2019 Annual General Meeting, and with the December royalty notifications in 2017, 2018 and 2019.

The **FINAL** phase of the revised system will be implemented in **December 2020**.

**All JAMCOPY affiliates must be re-verified, that is your eligible works and personal data updated with JAMCOPY– in order to benefit from royalties under the Revised Distribution Model.**

Under the revised model, royalties will be paid based on the number of eligible works an affiliate has in the JAMCOPY repertoire.

We thank those affiliates who have submitted their revised Affiliation Agreement between 2018-2019.

Affiliates who have not done so are urged to submit the revised Agreement IMMEDIATELY.

**Failure to submit the Revised Affiliation Agreement and update the Works Data can result in you not receiving all possible royalties.**

The onus is on you to ensure that JAMCOPY is in receipt of:

- The Revised Affiliation Agreement, completed and signed by you. The blank form can be downloaded here
